## Memorandum of Understanding

Between

ASIA UNITED ARCHITECTURE ASSOCIATION

And

PVP College of Architecture

This Memorandum of Understanding (MoU) is hereby made and entered into by and between Asia United Architecture Association, hereinafter referred to as "AUA", and, PVP College of Architecture, hereinafter referred to as "PVP".

### 1. PURPOSE

The purpose of this MoU is to set for the terms and understanding between AUA and PVP to promote their co-operation in the Asian Contest of Architectural Rookie's Award.

### 2. BACKGROUND

The purpose of AUA Association is, by means of pairing education with practice in architectural design, to conduct business creating platform on which Asian countries can achieve sustained growth and development together through creative cultural collaborations, which will establish a rich network associated with Asian architecture and encourage mobility among students, architects, educators, researchers, business operators related with architectural design.

In order to activate and develop Asian architectural culture, AUA holds an annual architectural contest for the students (the Asian Contest of Architectural Rookie's Award), and various events related with architectural design. The contest allows the Agree on the purpose and scope of AUA and join a discussion about the development of architectural education in Asia.

### 3. MEMBERSHIP

PVP shall become a member of AUA EDUCATION, an education sector of AUA.

#### 4. AUA SHALL:

- Host the Asian Contest of Architectural Rookie's Award.
- Coordinate domestic contests of each country.

#### 5. PVP SHALL:

- Agree on the purpose and scope of AUA and join a discussion about the development of architectural education in Asia.
- Responsibly hold a domestic contest in India, and fairly select two national representatives for the Asian Contest of Architectural Rookie's Award.
- Agrees to the use of its name on the AUA website and the official Asian Contest of Architectural Rookie's Award website after signing the MoU.
- Cooperate on the organization of the domestic contest and the Asian Contest of Architectural Rookie's Award held in India.
- The national representatives' shall themselves cover the entire cost of travel to and from the country where the Asian Contest of Architectural Rookie's Award is held. The same clause has been added in the domestic competition which will ensure that the selected students will be able to fund themselves for their travel to the place of jury.

#### 6. COMMENCEMENT, RENEWAL, TERMINATION

This MoU will be effective from the date of the last signature hereto and will remain in force for a time period of three (3) consecutive years, with a possibility for renewal at the end of the three-year-period, subject to the Parties' written agreement. Either Party may terminate this MoU by giving six (6) months' notice in writing to the other Party.

This MoU has been drawn up in two (2) original copies in the English language, each Party receiving one duly signed copy hereof .

MEMORANDUM OF UNDERSTANDING BETWEEN  
ISOLA (INDIAN SOCIETY OF LANDSCAPE ARCHITECTS)  
AND  
VIT'S PVP COLLEGE OF ARCHITECTURE, PUNE

This Memorandum of understanding (herein after referred to as MoU) is made on the 5th day of March Two thousand and Twenty between Indian Society of Landscape Architects, (herein after referred as ISOLA) on one part and, VIT's Padmabhshhan Dr Vasantdada Patil College of Architecture, Pune (herein after referred as PVP COA, Pune) on the other as collaborative institutions.

WHEREAS ISOLA and PVPCOA,Pune, have agreed to carry out the Collaborative Partnership Programme, herein after referred to as the "MoU INITIATIVE ", jointly with diligence and efficiency as desired in this MoU and in conformity with appropriate administrative, financial and educational practices and to implement all such plans and activities and reforms as required for the Programme.

NOW, THEREFORE the ISOLA and PVPCOA,Pune agree to enter into collaboration between the two Institutions in terms of UNDERSTANDING here below.

## 1. OBJECTIVES FOR COLLABORATION

The objectives of the MoU are

- a. To help students in excelling in the subject of Landscape Architecture, by gaining professional and practical knowledge from practicing ISOLA members
- b. To jointly conduct design Studios, seminars, symposiums, training programmes, workshops keeping Landscape Architecture as focus including Architecture and related/ allied fields.
- c. To explore possibilities of research interactions/ exchanges amongst ISOLA research center and faculty / research center of institute.
- d. To develop learning resources, teaching aids etc. by carrying out experiments for 'educational' as well as 'research and development' purposes& development of profession in general
- e. To enable the exchange of data relevant for pursuing academic goals.
- f. To effectively share the human, intellectual and infrastructural resources for furthering the standard of education and profession in the field of Landscape Architecture.

## 2. IMPLEMENTATION AND MONITORING

For implementing and monitoring the Programmes envisaged and taken up from time to time under this

MoU, ISOLA and PVPCOA,Pune jointly agree to:

- a. The ISOLA through its Maharashtra chapter shall establish and authorize 'MOU Initiative committee' at PVPCOA,Pune which will be headed by one faculty member of that institute who shall be an ISOLA member.
- b. The ISOLA and PVPCOA,Pune will constitute coordination committees in addition to the MOU Initiative committee if required for consistent communication, monitoring of the activities and achieving the set targets. Committees will interact at least once in three months and review the progress.
- c. In case the activities envisaged under this MoU lead to / result in research findings suitable for publication, the credit will be shared equally. If the activities envisaged under this MoU result in the development of data base, suitable for patenting, then the Intellectual Property Rights (IPR) will rest equally with both the institutions.
- d. It is recommended that the Institute as part of the MoU undertakes the 'ISOLA Mentorship Programme' ; referred as ISOLA MP hereafter; minimum once in every two years in the form of interactive sessions, symposium or a workshop, towards achieving capacity building of the faculty members for imparting quality education in Landscape Architecture. It is also recommended for the institute which is seeking or in process of starting the master's course in landscape architecture, to enrol for the ISOLA MP before starting the course.



c. The institute will select a representative from their institute (preferable the coordinator/ Head of the Department who is responsible for the landscape architecture education in the respective institute), who is also an ISOLA member, as a one point contact for the ISOLA – education board. The name and the contact details of the representative will be conveyed to ISOLA by the institute as part of the MoU. This is to facilitate a continuous dialogue with the institute in order to fulfil the objectives of the MoU.

### 3. FINANCE

Regarding the financial arrangements during the implementation of the Programme, ISOLA and PVPCOA, Pune further agree as under:

- a. Both the institutes will engage services of the existing faculty and staff for carrying out the activities planned under this MoU. A self-volunteered initiative is expected.
- b. Both the institutes will utilize existing and agreed infrastructure and resources for carrying out the activities and share all necessary facilities available to make programme a success.
- c. Activities under this MoU are NOT for fund raising. Expenses necessary for accomplishing this purpose shall be incurred by ISOLA and Institute respectively without any claims made to the other side.

### 4. INDEMNITY

Both parties hereby indemnify and undertake to keep indemnified and protected the other party and their respective officers and employees from and against any claims or actions arising out of or in any way relating to the provision and implementation of the Programme as per this MoU.

### 5. DURATION

This MoU will be valid for a period of TWO years from the date of this MoU subject to periodic revision and/or extension.

### 6. AGREEMENT

The two signatories of this MoU, viz., the ISOLA PRESIDENT and Principal of College of Architecture in case of B.Arch course (in case where there is no Masters Course in Landscape Architecture) / Head of the Landscape Architecture Department (in case where there is a Masters course in Landscape Architecture) PVPCOA, Pune agree to act in good faith and in a spirit of mutual understanding to facilitate the achievement of objectives set under the Programme.




